

It is with great pleasure that I present you with the annual report of the Veterans Assistance Commission of Mason County, Illinois, pursuant to Chapter 330, Part 45, Section 8 of the Illinois Compiled Statutes.

As the foremost veteran advocacy agency in Illinois, we are a small county providing services for Mason County Veterans in the following categories:

- 1.) Advocacy
- 2.) Benefits Application Filing and Claims Management
- 3.) Financial Assistance for Veterans

In Fiscal Year 2023, ending on November 30<sup>th</sup>, our Commission was able to help our veterans with a total of \$7,272.00 for Transportation, Rent, Utilities, Groceries and Miscellaneous. I helped our veterans by assisting them in accessing VA health care and helped get \$176,688.56 in VA compensation, and I am helping Fulton County file claims for VA health care and helped get \$140,948.40 in VA compensation. I am helping Tazewell County file for VA health care and help get \$3,203.90 in VA compensation. I am helping Cass County file for VA health care and help get \$10,616.57 in VA compensation. I am helping Sangamon County file for VA health care and VA compensation. Making the total VA compensation \$338,541.39 for our veterans. Since getting the Mason District Hospital into the VA Community Care program they have been seeing veterans from several counties using this service, making it an asset to the community. Consequently, the Commission continues to be a significant governmental entity at the county level.
