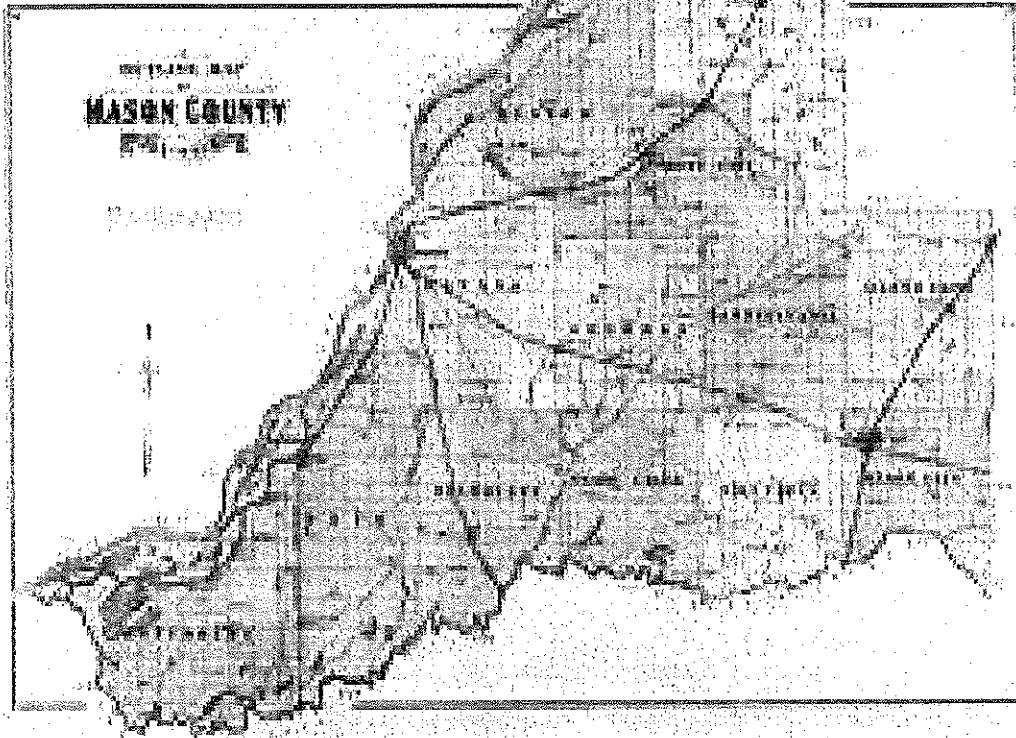

It is with great pleasure that I present you with the annual report of the Veterans Assistance Commission of Mason County, Illinois, pursuant to Chapter 330, Part 45, Section 8 of the Illinois Compiled Statutes.


As the foremost veteran advocacy agency in Illinois, we are a small county providing services for Mason County Veterans in the following categories:

- 1.) Advocacy
- 2.) Benefits Application Filing and Claims Management
- 3.) Financial Assistance for Veterans

In Fiscal Year 2024, ending on November 30th, our Commission was able to help our veterans with a total of \$7,480.00 for Transportation, Rent, Utilities, Groceries and Miscellaneous. I helped our veterans by assisting them in accessing VA health care and helped get \$320,292.85 in VA compensation, and I am helping Fulton County file claims for VA health care and helping get \$189,359.08 in VA compensation. I am helping Tazewell County file for VA health care and help get \$5,891.00 in VA compensation. I am helping Cass County file for VA health care and help get \$10,203.92 in VA compensation. I am helping Sangamon County file claims for VA health care and help get \$56,060.20 in VA compensation. I am helping Peoria County file for VA health care and help get \$6,884.24 in VA compensation. I am helping Schuyler County file for VA health care and VA compensation. Making the total VA compensation \$588,691.29 for our veterans. Consequently, the Commission continues to be a significant governmental entity at the county level.
